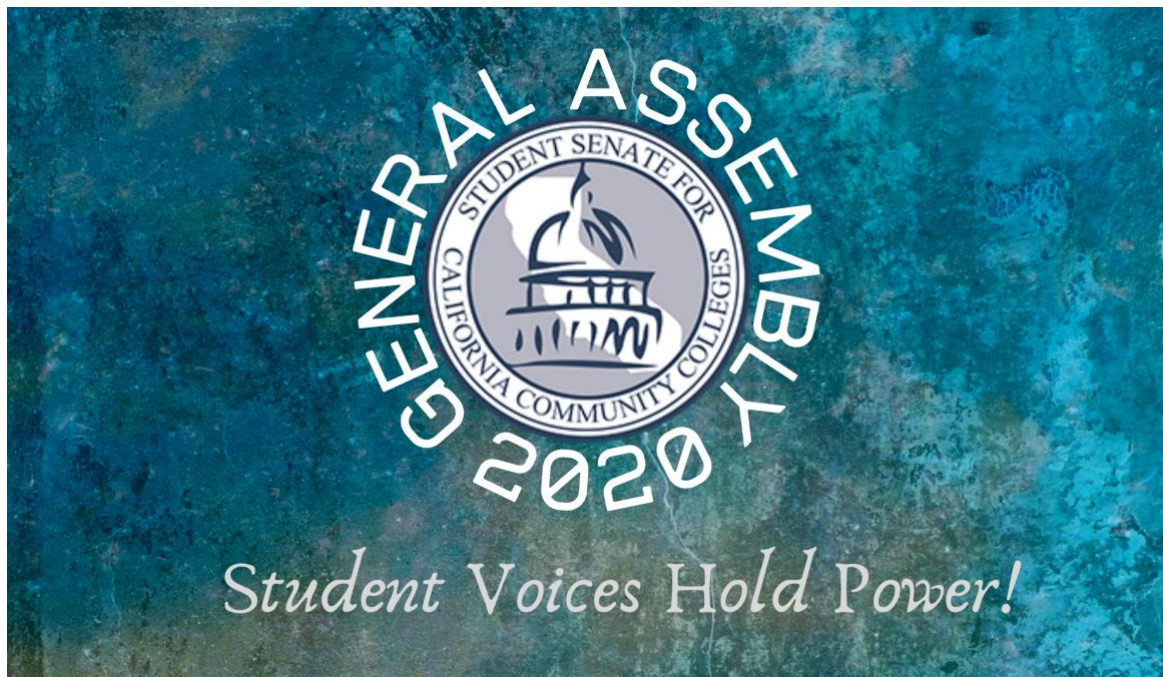

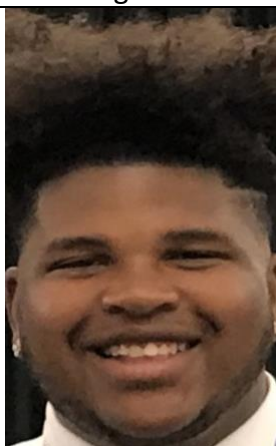

To the Student Senate for California Community Colleges,

My name is Gabriel Kelvin, I've been elected to a variety of student leadership positions since my enrolment. These include a club president, student council member and later Victor Valley College ASB President/Student Trustee, Region IX Treasurer, President of the Student Trustee Caucus of California Community Colleges and student representative to the Financial Aid Regional Representatives. I work full time as a news editor/reporter for my city's newspaper, have interned at my local assemblyman's office and have over a decade of experience with basic needs and education nonprofits.

I consider myself above all a reformist, and my platform is very simple, born out of frustration at the current state of the student voice across the state. Presently, our constituents, community college students, have little to no knowledge of who we are outside of the people who charge them a two dollar fee, there are system wide participatory governance committees that have an empty student seat because we didn't fill them, and our legislative presence is minimal at best. Our three foundational pillars are crumbling, and as we enter into the next year, receiving \$4 million to operate with, if we do not take action in restoring these, the Student Senate will be crippled permanently.

In my tenure I've worked on everything from ASO constitutions, financial codes, grants, editorials (according to presidential duty 5), and assembly bills. I've made personal contact with the UC Student Regent Hailey Weddle, CSU Student Trustee Juan Garcia, ED for TICAS Laura Szabo-Kubitz, State Senators Scott Wilk and Connie Leyva (CA Senate Higher Education Committee), the statewide student organizations in New York and Utah, dozens of newspapers and also nonprofits, education organizations and multiple colleges. I was part of the team that coordinating fighting to get Gavilan College priority registration for their student leaders and also was one of the two principle lobbyists and workers for AB 2910, which is aimed at empowering your student trustee by possibly receiving a vote on their boards.

These skills and experiences I hope to channel into my executive committee and the Board of Directors to give power and direction to our delegates. My goal is to create a comprehensive platform of our values, what we believe and what services/facilities should or should not be on each campus, and fight with administrative policies, board policies and diplomacy to have these realized on our campuses. The changes that you specifically have been wanting to make on your campus – my goal is for you to see the Student Senate as an ally and source of information and support to talk to administrators and finally get the health centers, food pantries and undocumented student resource centers we've been advocating for all these years.

The issue closest to my heart is basic needs/financial aid reform, as I lost my father when I was 14 and grew up in poverty thereafter. Inclusive of that, my priority is advocating into policy the resolutions given to the SSSCC for years, as the list of resolutions we haven't even touched grows each year and include everything from affordable textbooks to support for homeless students to basic needs to health centers. I would believe it undue if any candidate's personal platform had anything but working on what our colleges already told us they want and need us to work on. And finally, my third foundational passion is to end the drama, conflict and ego that has plagued student leadership and the Senate for so long. We cannot fight these battles if we are fighting amongst each other, and after a year of being personally attacked, humiliated and undermined for trying to advocate for change, I've decided to run for this position to finally end this unacceptable behavior.

I do not ask for your vote lightly. I ask for it with great humility and responsibility. Our voice is stronger together and too long the focus has been on power plays and titles. I seek to change our identity to one that is efficient, respected and just as impactful as our administrative counterparts. By voting for me, know that you are voting for someone who understands the struggles of community college students, who owes his life to this system, and wants the student voice to empower and guide our colleges to transform our communities, state and world for the better.

My story as a community college student inspired me to become an advocate for state-wide issues like basic needs, legislation for dreamers, and the power of having a full vote as a student trustee. Working alongside my legislative affairs director and regional team, I made sure that others' stories wouldn't go silent either and instead became vocalized in the capitol. As VPRA, my platform is focused on three priorities, increasing connection between the executive board and the delegates, developing regional institutional memory, and building regional communities.

If I were to be elected, my first three projects would be to start working directly with the advisors of each community college to ensure strong relationships with the SSCCC, running state-wide orientation webinars for incoming delegates and regional officers, and ensuring each region has drafted a budget and fundraising plan for the year as well as a list of events that will bring colleges together.

# Candidate: Toni Schiffmaier | Position: Vice President of Finance

## College: Folsom Lake College

My name is Toni Schiffmaier and I am a Pre-Law student double majoring in Business Administration (with a specialization in Finance and Nonprofits) and Psychology. Over the last year, I have been very involved in student advocacy on local, regional, and statewide levels serving within student senate finance. On a local level, I established the Folsom Lake College Business Association (to provide more opportunities to students wishing to enter into business), and the Basic Needs Committee. On a regional level, as the Region II Treasurer, I was one of the first to establish a Regional Finance Committee, where we were able to create a new financial policy, and are currently working towards planning a fundraiser for the region. As the Statewide Finance and Fundraising Committee Vice Chair, I was involved with the restructuring of the finance committee, creating marketing plans for the \$2 Student Representation Fee and AB 1504, and working towards ways to allow regions to raise funds through avenues outside of asking their ASOs through being the Regional Fundraising Policy Chair. Because fundraising through other avenues wasn't previously an option, many regions had a lack of funds over the last year, so I sought a solution with the guidance of the current Vice President of Finance and Interim Executive Director Julie Adams to make this happen.



I want to present my candidacy to become the SSCCC Vice President of Finance, because I believe that student representation is vital to student success and the future of the California Community College system. We, the 2.1 million students within the California Community College system, are a part of the largest higher education system in the nation. The student leaders within our colleges not only represent their students, but make decisions that change how our economy is structured. We've done this through increasing equitable funding for CCC students with the successful passing of AB 1504 over the last legislative session. We've advocated for AB 302 in order to provide homeless students a safe place to sleep, and worked towards increasing college access through better financial aid funding with SB 291.

The biggest issues we are seeing affecting California Community College students center around basic needs and mental health. For this reason, my platform for the SSCCC this year is to tackle increasing access to Basic Needs/Mental Health Funding, Affordable Student Housing, and Regional Activities Fundraising, through legislation, regional implementation, and seeking funding for the startup of Basic Needs Centers. With housing prices becoming increasingly expensive in our economy, basic needs are becoming harder for students to afford. As a candidate who is passionately dedicated to student representation, it is my focus to put student priorities and needs first through increasing the student voice on local, regional, and statewide issues. I would greatly appreciate your consideration to vote for me as your SSCCC Vice President of Finance, so we can make a difference in our local, regional, and statewide systems together.

My name is Emilio Salas and I'm running to be your next Vice President of Communication. Currently I'm enrolled at Folsom Lake College majoring in Administration of Justice. I believe that I am qualified for this position due to my involvement with the world wide organization of YoungLife where I worked at the local level as a leader with both middle and high school. As a YoungLife leader it is my job to not only hear the concerns of YoungLife kids but also to address the concerns and support them through mental health and life challenges. My job also includes sending out information through social media platforms to inform them about local events as well as to inform kids about opportunities to serve their peers. My leadership position has taught me how to plan fundraisers, camp dates and more efficient ways to support kids along with making their voices feel heard. I made the decision recently to decline positions as a Cast Member in Florida for the Disney College Program because I felt that it was more important to help the student in the present and future

I currently advocated for students through my school's ASO by holding the position of Vice Commissioner for Clubs and Events Board, Senator, and resolution officer. I have lobbied for Senate Bill 291 which would focus more funding on need-based grants. I have promoted advocacy by informing students how to participate in SSSCC student engagement events. I have and am currently serving on ASO, region, and statewide committees such as being the chair of Aramark (food service provider) committee, vice chair of De-stress week committee, member of region II legislative affairs and rules and resolution committee, and recently becoming a non-voting member for the SSSCC events committee. When news was received during COVID-19 campus closures, many students expressed fear about losing their jobs. As a response, I contacted the chancellor to advocate for temp classified and students employees to still receive a source of income throughout the district's campus when COVID-19 arised.

A few main priorities of mine include Foster Youth, Mental Health, and Granting full voting rights to student trustees. Mental health is important because I myself have dealt with depression and PTSD from being bullied in the past. The foster care system has helped me through many struggles and it's important to help those who struggle with higher education and mental health within the system. I believe the student trustees should have full voting powers because they are the elected representatives by the students. They carry out the student concerns and deserve to have more equitable power. I plan to bring more awareness to student concerns and issues through an SSSCC podcast, and attend regional delegate assembly meetings. I would also like to increase student involvement in the SSSCC by reaching out to local colleges and connect with campus media departments to bring awareness to SSSCC events.



My goal as VPC is to create an environment which promotes equity and acceptance to enrich the students' experience through new ways of communication and reaching out. Becoming the Director would be an incredible opportunity for me to continue sharing my innovative ideas and making a positive difference in SSCCC. I am focused on the students' needs and stories. I am an ESL first generation student, hence I do have the patience and understand the importance of being heard in order to make a change. I have been a student in the Community College System for 3 years, and during that time I have learned a lot about the students, faculty and campus, and I have learned how to identify and resolve the problems that arise within our communities. This year, I crafted a resolution to purchase laptops for library, so students can access homework at home during the pandemic. Also, I promoted and co-sponsored availability of feminine hygiene products for free in most bathrooms on campus. Currently, I am engaged in addressing the evolving situation on COVID-19 with administration and finding solutions to students' concerns due to transition to online teaching and other urgent changes both locally and statewide. I continue to collaboratively and efficiently represent the Student Trustee Caucus as a Secretary in order to help student leaders across the state get the full voting rights. The introduction of the AB2910 was the result of the diligent partnership between the Caucus and the SSCCC this year. The advisory vote is there to ensure that students will not be represented equally at the table. Hence, it is my promise to you to make your voice heard on the state-wide level.

Over the prior years, I have accumulated a great deal of experience with overseeing meetings, organizing events and fundraising through my job in Human Resources as well as being a Student Trustee/President and Director of Public Relations. Though I would be working mostly on improvements for the SSCCC, the biggest statewide issue for me is Housing & Food Insecurity, having personally been affected by it while currently in the SSCCC.

If elected by the delegate assembly, my first three priorities would be establishing a youtube channel for educational and informational about the SSCCC, updating the brand standards for the SSCCC, and working to update the website to easier access for all.
