- II. Full activation of all college ASOs across the state, we can all agree that the student voice is heard more loudly when all colleges participate, that's why I would make activating all inactive colleges one of my biggest priorities. As a RAD, full activation of all nine of my region's colleges is one of the biggest priorities to increase student involvement and the student voice. RAD's are essential for lifting the student voice and as VPRA I promise to support all RAD's and Regional Officers.
- III. The creation of institutional memory within all of our Regions. Institutional memory is the very bedrock of any successful organization and as VPRA I would create the framework and foundation for successful implementation of institutional memory policy. As RAD, it is my duty to build the memory in order for our region to continue after we're gone, and as your VPRA, I will do exactly that so that we can insure for years to come that the student voice will not be neglected.

Persisting Issues

While the SSCCC has improved tremendously over the last few years, there are a few problems that persist. One, as made apparent by the current makeup of the incumbent executive board, is diversity among board members. Generally the SSCCC has been cognizant of ethnic diversity, but executive officers of regional and statewide boards have tended to come from the centers of jursidictions indicating that the SSCCC hasn't found an effective way to maximaze its reach and influence. Additionally, I have encountered many Associated Student Organizations (ASOs) that are hesitant to participate in SSCCC activities indicating that ASOs have needs or desires not currently being addressed by the SSCCC.

Plans if Elected

If elected I plan on using my company marketing experience to extend the reach and influence of the SSCCC to the farthest corners of California. While doing so, I will work to establish pathways for our leaders from boarder colleges to attain roles in regional and statewide shared governance. This will also give me the connections needed understand and address concerns from local ASOs as well.

Why me?

My experiences heading marketing operations at Corffee Stone Law Corporation and promoting participation amongst colleges in Region II have given me the tools I need to ensure the SSCCC not only incorporates the voice of students from all 115 colleges, but the students themselves. My diverse set of experiences also allow me to develop intuitive ways to address issues often not seen by my colleagues. Finally, I'd like to say that simply because someone else is from a boarder college, doesn't mean they would be better at promoting participation from those schools than I. I have already developed knowledge on the issue and devised ways to address it as well. If I can convince businesses to have a small business represent them over a large law firm with a simple letter, then I can convince ASOs to coordinate with the SSCCC because it will amplify both of our voices and further their students' leadership careers.

Basic Needs

That is why it is important for our government, in an attempt to contribute to further student equity, to provide for basic needs as best they can.

Priorities

1. Regional Activity

Some regions have faced periods of inactivity or difficulty in reaching out to their colleges, as some are distrustful of the Student Senate. I will provide myself as a resource in the campaign for increased regional activity. Working with each region's executive board, we as the Student Senate will see more college ASO's at each region's Delegate Assembly. Regional activity is important, not only for the regions themselves, but the Student Senate as a whole as regions are the backbone of the Student Senate.

2. Regaining Trust and Confidence

As I previously stated, some college ASO's are distrustful of the Student Senate or lack confidence in its abilities. It is important that the Student Senate tackle this in a manner most befitting: communicating with each college's ASO. Distrust among our ASOs will hinder the Student Senate's mission for student interests.

3. Continuity

The transition of power and duties is critical to the Student Senate's mission and success. Without this smooth and proper transition in our Regions, the Student Senate can be left weaken and its influence can shrink.

FOR VICE PRESIDENT OF REGIONAL AFFAIRS

My name is Francesca Mejia and I am running to be the next Vice President of Regional Affairs (VPRA) for the Student Senate for California Community Colleges. I currently serve as a Senator on the Associated Students of Napa Valley College, and a delegate for Region II of the SSCCC, as well as Vice Chair of the Legislative Affairs Committee for my region. I have a passion and dedication for advocacy, and I would be humbled and honored to continue my service for the SSCCC and serve on the Executive Committee.

My choice to attend a community college was like that of many other minority and low-income students who could not afford to go straight to a four-year university. As a student in the California Community College (CCC) system, I learned that it was often more expensive for students to attend the CCC's instead of the UC's or CSU's due to the high cost of housing expenses. CCC students are more likely to experience homelessness or housing insecurity. As someone who has experienced the difficulties of maintaining a minimum wage job, attending school full-time, and making rent payments, I want to help the millions of students like me who are struggling to afford college.

I was fortunate enough to be the SSCCC delegate for my college, where I had the opportunity to lobby at the capitol for bills that sought to make the CCC system more equitable and accessible. These bills included AB302, a bill that allows homeless students to sleep in campus parking lots in their cars overnight, and SB291, a bill that seeks to cover the true cost of attending a community college. It was over the year that I spent in my position at the SSCCC that I learned the importance of advocacy and the impact and power of the student voice. The statewide issues that I am most concerned with are covering the full cost of attendance for community college students, legislation for undocumented students, and funding basic needs centers.

I feel an obligation to continue my journey in advocating for the 2.2 million CCC students whose voices so desperately need to be heard. I am running for Vice President of Regional Affairs because I want to empower student leaders like myself to connect with students from other colleges and build a strong network of advocates who will shape educational policy and legislation.

If I were elected, my first three priorities would be the following: Firstly, to ensure that each of the 115 CCC's has a delegate to represent their college in the SSCCC, I would communicate frequently and directly with the advisors of each college, as well as the Regional Affairs Director for each region and provide them with informative resources on the SSCCC, such as our history and mission. Secondly, I would frequently attend meetings of each SSCCC region in order to ensure direct communication and support from the executive committee year-round. Lastly, I would organize and provide webinars and presentations that would provide delegates with an overview and orientation to their role in the SSCCC.
