My name is Jacob Roe, and I serve as the Tribal Liaison for SSCCC. I first joined the SSCCC as the Region II Intern in August 2024 and am honored to support American Indian and Alaska Native students across the system.

While attending Sierra College, I helped launch the Native American Student Support and Success Program and served in governance roles both locally and statewide. I now study at Stanford University, focusing on California Indian law and politics, and continue working alongside California Indian non-profits and Tribal Nations. As an enrolled member of the Georgia Tribe of Eastern Cherokee and a lifelong resident of Nisenan and Miwuk Country, I find purpose in ceremony and in advancing Native academic excellence and civic empowerment.

Through this role, I aim to uplift Native student leadership, bring visibility to the systemic challenges facing California Tribal communities, and build stronger partnerships between Tribes, Nativeserving programs, and the SSCCC.
