# 2022 Professional Development and Leadership Training

Based on the feedback we have received, the SSCCC 3rd Annual Professional Development and Leadership Training event in San Francisco September 30th and October 1st was a successful event!! About 200 students and advisors attended the event in person and online.

The first day, our students were inspired by our keynote presenter Dr. Abdimalik Buul, an award-winning professor, antiracist activist, and emancipatory educator who has led statewide efforts in race-conscious practices and antiracism trainings. The rest of the day, participants enjoyed workshops and networking opportunities.

The workshops provided on the first day centered on topics dedicated to SBAs (Meeting Management, Marketing your SBA, Basic Advocacy); student leaders (Start a Political Campaign on your Campus, Promoting Change, Get out the Vote); as well as personal issues Continued...











Dr. Buul, visiting executive of educational excellence at the California Community College Chancellor's office, delivered the keynote address to the Professional Development Conference both physically and virtually. Challenging the students to evolve from their experience through COVID, he urged students to become sensory leaders. It is their job not just to lead because of their title or position but to lead by emotions through character, empathy, and understanding. The Deferred Action for Childhood Arrivals (DACA) program remains uncertain, particularly given the most recent consequential decision by the Fifth Circuit Court of Appeals to uphold the State of Texas, et al., v. the United States (2021). This decision ruled that the DACA program is unlawful and will now head to the lower courts to question its legality. Now more than ever, the SSCCC is vigorously committed to continue our support and advocacy for our DACA student recipients to continue their higher education goals without fear of deportation. This court ruling is a direct violation to the diverse, equitable, and inclusionary efforts flourishing within our system and we will continue working closely alongside our system partners, the California State Legislature, and the Governor's Office to ensure the academic protection and well-being of our students. The SSCCC stands firmly in solidarily with our students during these times.







### **Participatory** Governance

The SSCCC continues to seek out students to serve on statewide participatory governance groups. Below are task forces or advisory groups that need student representatives:

Baccalaureate Degree <u>Program Workgroup</u> Makes recommendations on implementing the expanded requirements of developing CCC Bachelor's Degrees.

Common Course Numbering Develops an implementation plan for fulfilling the AB 1111 mandate.

#### **UC Transfer Pathways** Taskforce

Monitors implementation of the provisions as well as assess progress and effectiveness of activities outlined in and deriving from the MOU between the groups.
